# 2024 Legislative Updates

- ►\$14.6 Million for HCBS (state share)
- Case Management
  - Lowering Case Manager : Individual ratios
- ►\$3 Million for Home Health increases
- ►\$2.1 Million for Mental Health providers
- \$1.7 Million to buy down ID Waiver slots
  Approx 60 to 70 slots
- \$1.4 Million for Supported Community Living for Children

# 2024 Legislative Updates

- Increases for PT and OT
- PMIC Reimbursement Structure
- Rate increases for Community Mental Health Centers
- Rate increases for Air-Medical Transports
- Increases for DME supplies and providers
- Increases for Certified Nurse Midwifes
- Extended post-partum coverage



### Hope and Opportunity in Many Environments (HOME)

- Iowa HHS rebranded its name for the Community-Based Services Redesign.
  - The new name is Hope and Opportunity in Many Environments, or HOME.
- The new name better reflects the hope that comes with having the ability to choose where to live and what services you receive from Medicaid.



# Waiver Redesign Specifics



Changing from 7 disability-specific waivers to 2 age-based waivers with wider eligibility.



Developing "tiered" budgets that allocate resources for eligible people based on their needs.

## **Proposed New Waiver Structure**



ELIGIBILITY & ENROLLMENT | To be eligible, individuals must meet two criteria: (1) they need the level of care that would be provided in an institution, and (2) their disability fits into one of the categories below.

## HOMEwork in 2024

Identified a tool used to screen and prioritize waitlist members Conducted focus groups on the functional assessment process Completed more than 3,000 Needs on Waitlist surveys to collect information from people on the waitlist about their needs

Developed plan to assess provider capacity

Worked with MCOs on case manager ratios

# Behavioral Health System Alignment – Why?

**Current State** 

- Iowans don't know how to access services
- Health outcomes are not satisfactory
- System-wide duplication

**Future State** 

- Iowans have consistent access to health and human services
- Use funding more effectively to achieve outcomes
- Consolidate and streamline contracting and administration

### BH System Assessment

- HHS worked with Health Management Associates (HMA) to conduct an assessment.
- HMA's recommendation report includes:
  - An overview of the service delivery areas
  - Proposed funding models for the local HHS systems
  - Identification of Iowa Code and Iowa Administrative Rules impacted by the recommendations.

### **7** Town Halls

#### 35 Stakeholder Interviews



# The Case for Behavioral Health System Alignment

Significant Need	<ul> <li>Nationally, 38.3% of adults aged 18 or older with any mental illness reported unmet need for mental health treatment due to not knowing where to go for services (2021).</li> <li>Nationally, 17.9% of individuals 12 or older reported unmet need for substance use treatment due to not knowing where to go for services (2021).</li> <li>13.5% of lowans reported experiencing frequent mental distress in 2022.</li> </ul>
Incentive Fund	<ul> <li>Currently, the incentive fund includes \$23,955,429 in unspent dollars by the Mental Health and Disability Services (MHDS) regions.</li> <li>Areas in need of support include statewide efforts such as 988, Your Life Iowa and the development of Certified Community Behavioral Health Clinics (CCBHCs).</li> </ul>
Ongoing Litigation	• Both the Children's Mental Health lawsuit and the DOJ consent decree target areas of inconsistent support by MHDS regions: crisis services for children and services for individuals with disabilities.
System-wide Redundancies Exist	• Certified Community Behavioral Health Clinics (CCBHCs) will transform the provider network in Iowa. Review of existing structures in the behavioral health safety net and continued system alignment will be critical.
